PROGRAMS INCLUDE COLLEGE OUTREACH, SCHOLARSHIPS, MENTORING, JOB AND INTERNSHIP PLACEMENT, AND PROFESSIONAL/ACADEMIC DEVELOPMENTS WORKSHOPS AND SEMINARS. THE ORGANIZATION'S SCHOLARSHIPS ARE INTENDED TO CLOSE SHORTFALLS BETWEEN THE AMOUNT OF MONEY OFFERED IN THE FINANCIAL PACKAGE FROM A UNIVERSITY (GRANTS, LOANS, AND WORK STUDY) AND THE ACTUAL COST OF A STUDENT'S COLLEGE EDUCATION. IN SOME CASES, THESE SHORTFALLS WOULD PREVENT STUDENTS FROM ATTENDING COLLEGE ALTOGETHER. SCHOLARSHIPS RANGE BETWEEN \$1,000 TO \$3,000 PER SCHOLAR, AND ARE RENEWABLE FOR UP TO 6 YEARS.
